The Pavilion is made available to the residents of Johnstown Township through generous grants and Township public funds. The facility is monitored through video surveillance and is regularly inspected by Township staff.

Reservations	<i>A Johnstown Township resident must complete the application and be in attendance during the entire event. Reservations are considered upon completion of Pavilion Rental Application and payment of applicable fees. Please note you are reserving only the Pavilion. You will not have access to the Township Hall as part of this rental. Additionally, the playground and walking path remain public use spaces.</i>
Fees	<ul style="list-style-type: none"> • Daily Rental (nonrefundable): Pavilion only: \$50 OR Pavilion with electrical service: \$65 • Security Deposit (refundable): \$50* • Please write two checks: one for Rental Fee, the other for Security Deposit. Please make checks payable to "Johnstown Township." *If paying security deposit via cash, it is your responsibility to pick it up after rental, it will not be mailed to you.
Pavilion Hours	Pavilion is open daily dawn to dusk.
Prohibited Items and Actions	<p>The following are prohibited:</p> <ul style="list-style-type: none"> • alcoholic beverages • illegal drug use; tobacco, e-cigarettes, and marijuana • sporting use of firearms (i.e., hunting or target practice) • open flames or fireworks or any kind • any action that would endanger the safety of others using the premises • intentional destruction, damage, or removal of Township property • driving motorized vehicles on paved walking path or outside designated parking areas • leaving vehicles unattended overnight or in non-designated parking areas. Violators will be towed. • Fundraising events, garage sales, auctions, or other commercial activities (exception: Township-sponsored Farmers Market/Craft Show) • fighting or other violent activities • possessing illegal weapons • use of threatening, abusive, menacing, profane or indecent language or conduct • dumping household, domestic, or any other type of waste in the Township receptacles. • violating any federal, state, or local laws
Cleanliness	Please leave the pavilion and grounds in the same, or better, condition as when you arrived. If left untidy, your security deposit will be retained.
Pets	Dogs must be on 6-foot leash at all times. Waste Station is provided for cleaning up after your dog.
Authority	Local law enforcement or a Township employee may request any person(s) to leave Township grounds for any cause, at any time.
Use	Use of the pavilion is at your own risk. Johnstown Township assumes no responsibility for injury, or death, to any individual using these premises.
Terms	The terms of this agreement are subject to change whenever the Johnstown Township Board deems it necessary.
